- It is strictly prohibited to leave a driving vehicle unattended when the SBGuidance system is switched on. The driver is always responsible for the direction and course of the vehicle.
- To prevent injury or fire, replace defective fuses only with fuses of the same type and amperage.
- The SBGuidance the operating system is not able to detect and avoid obstacles. If there is an obstacle in your path, you will always need to take action for it to be avoided.

- In case of system failure or breakdown switch of the tractor and disconnect the electrical power source to avoid further damage. Contact your dealer for further instructions on how to repair your system.
- Always wear personal protective equipment when operating/adjusting/repairing the system outside of the tractor cab.
- In order to prevent power surges from occurring, always start the machine first, before initiating the SBGuidance control system.

PAY ATTENTION!

- Only touch the touch-screen with your finger or by using a special touch-screen stylus/pen. Operating the touch-screen with sharp objects may cause permanent damage to the screen.
- Always consult your supplier as to which products are best suited first before cleaning the touch-screen with chemicals or alcohol.
- If the terminal is not used for a long period, better remove the terminal from the tractor and store in a heated environment. This will extend the life span of the electronic components.
- To prevent theft, it is better to not let the terminal and GPS-antenna unattended in the tractor on the field.

1 ACTIVATION SLINGSHOT FIELD HUB

The next steps have to be completed to sign up a Slingshot Field Hub in the Slingshot Portal:

1. Open the link: <https://portal.ravenSlingshot.com/>
2. Login with username and password. When you do not have an account, create one by using *Request Account* (Figure 1). To make sure the account has the right permissions, please contact Raven Europe.

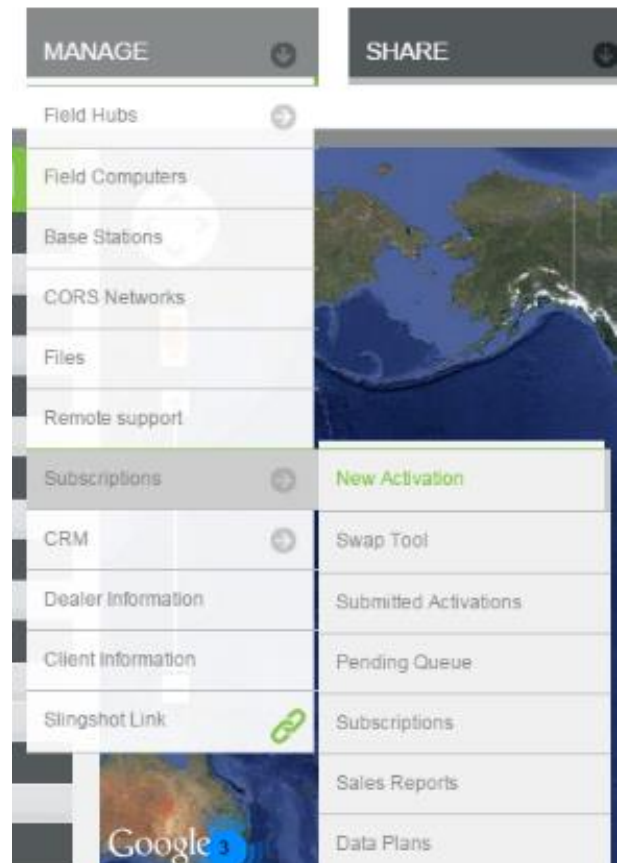


FIGURE 2 NEW ACTIVATION SLINGSHOT FIELD

3. When the account is correct and you are logged in, open *Manage > Subscriptions > New Activation* (Figure 2).

FIGURE 1 REQUEST SLINGSHOT ACCOUNT

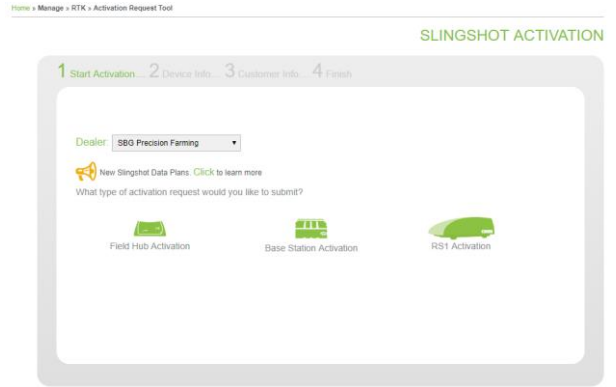


FIGURE 3 STEP 1 ACTIVATION PROCEDURE SLINGSHOT FIELD HUB.

4. A new wizard (Start activation) is now open, select *Field Hub Activation* (Figure 3).
5. A new wizard opens, enter the following information (Figure 4):
 - *Modem ID/IMEI*: This number is on the Slingshot Field Hub
 - *Cellular Data*: Select *No Data Activation Required*.
 - *Correction Unlock Options*: Select *Yes*.
 - After the checkmark 'yes' is set, the wizard expects more information for the Correction Unlock.
 - Select the option *CORS RTK*. After this option is selected the wizard expands again. See next page.

Step 3 of the activation form is to add a customer to the Slingshot Field Hub. At the top of this step is the name of the dealer, please check this before a customer is added.

If the name of the dealer is correct, fill in the customer information. When the customer is already a Slingshot Customer, you can search in the list of existing customers. When it is a new Slingshot customer, enter the information. It is needed to fill in all the information before the step can be finished. Select *Next* on the bottom of the screen. In the last step (*Step 4, Figure 8*) nothing has to be entered. Select *Finish* to finish the activation form.

2 REGISTRATION

At the installation of a CRx system the dealer has to register the Field Computer on the SlingShot Portal. This is a requirement for functionalities like Remote Support and receiving RTK signal (if ordered).

2.1 REGISTER FIELD COMPUTER

1. For the registration of the Field Computer on the SlingShot Portal some data is needed. This is the partnumber (P/N), the barcode, and serial number (S/N). You will find this on the back side of the Field Computer (Figure 9).
2. Now go to portal.ravenslingshot.com and log in. Go to Manage and press on Hardware Registration. Fill in the Part Number and Barcode. Note; both the Part Number and Barcode need to be filled in before the 'Hardware Found' message appears. At owner select the name of the dealer. At name fill in what type of terminal it is, so CR7 or CR12 and behind that the last five digits of the Serial Number (S/N). You will find the Serial Number also on the back side of the terminal. It is also possible to enter the name of the customer behind the serial number in the name textbox.
3. Now click on Submit, if everything went fine the following message will show up: Hardware Updated.

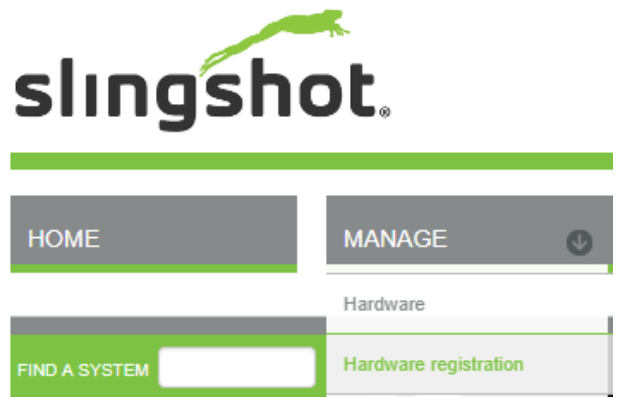


FIGURE 10 MANAGE HARDWARE > REGISTRATION

2.2 REGISTER RS1 ANTENNA

1. When a RS1 antenna is used click on Manage > Subscriptions > New activation on the SlingShot Portal (Figure 4). Select the Dealer and click on RS1 Activation.
2. Fill in the Modem ID, IMEI or ESN (d). The IMEI of the internal Slingshot can be found in the Slingshot UT at Cellular Information (Figure 4).

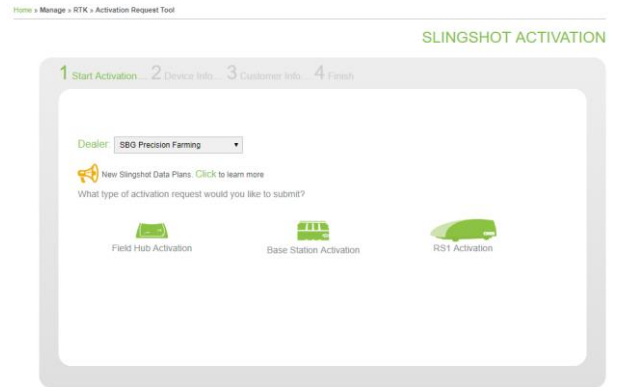


FIGURE 5 START NEW ACTIVATION

3. Select "No Data Activation Required" at Cellular Data. At Subscription Information a Silver or Gold subscription can be chosen. If the customer doesn't want to use RTK accuracy select "no" at Correction Unlock Options and press Save Device (figure 5).
4. If "yes" is chosen select CORS RTK and select the right CORS Network, Correction Format, Mountpoint, Username and Password. The customer will receive this information from RTK correction provider. Press Save Device.

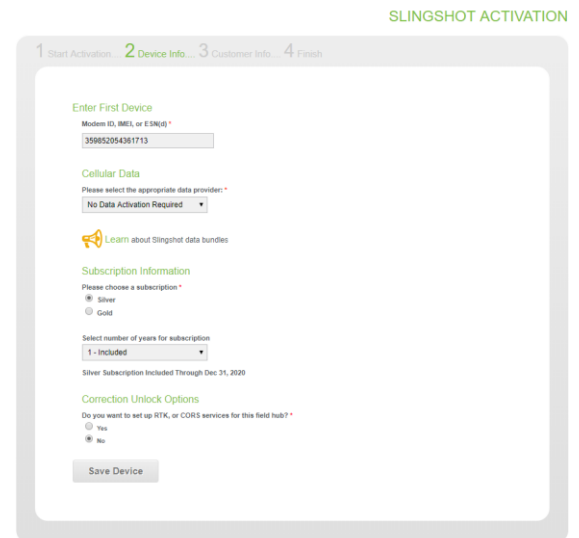


FIGURE 6 DEVICE INFORMATION

5. A new screen appears, press Next. Information of Customer must be filled in. When all the required fields are filled press Next (Figure 6). If there are any special notes then can be filled in the last screen of registration

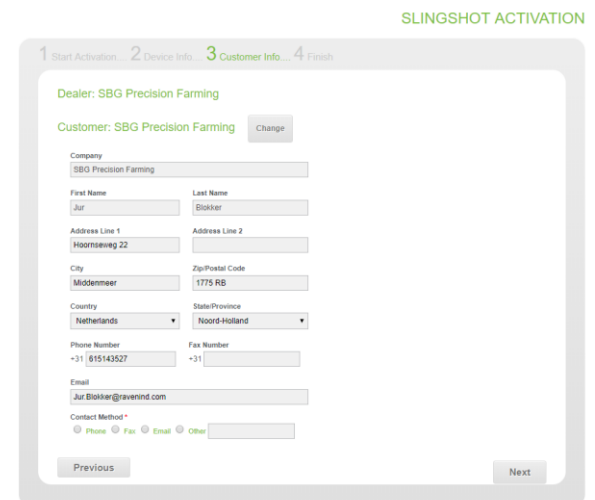


FIGURE 7 CUSTOMER INFORMATION
